SUMMARY: Designing, building, repairing wood-built items; identifying repair and/or replacement needs; assisting other skilled trades; completing projects safely and within established budget and time constraints; providing necessary information on the proper uses of the equipment; and ensuring adequate materials are available to complete assignments in a timely manner.

ESSENTIAL FUNCTIONS:

- Assemble cabinets and drawer bodies by hand, using a variety of hand tools, including, but not limited to routers, saws, power tools and table saws.
- Applying laminates using spray adhesives in spray booth; trim and file to finish
- Performs all necessary product preparation work by sanding, repairing and conditioning wood for priming, staining, painting, and finishing
- Install hardware such as hinges, handles, catches, and drawer pulls, using hand tools.
- Maintains tools and equipment, for the purpose of ensuring the availability of items in safe operating condition
- Coordinates with leads and supervisor and other trades for the purpose of completing projects/work orders efficiently
- Checks parts for aesthetics

COMPETENCIES:

- Ability to use calipers and micrometers
- Read and comprehend job tickets, drawings, quality policies, procedures, and standards
- Ability to inspect product to ensure compliance to standards
- Attention to detail
- Time management

WORK ENVIRONMENT: This job operates in a production environment. While performing the duties of this job, the employee is frequently exposed to fumes or airborne particles, moving mechanical parts and vibration. The noise level in the work environment is usually noisy and can sometimes be loud. Hearing protection is provided on a voluntary-use basis.
